Terms are net 30 days, with a 5-day grace period. Please do not make your Medicare & Insurance problems our problems. We are a small company and all of our vendors are also Net 30. We need two credit references and their phone #. We also need a credit card on file. If your account exceeds the grace period the amount past due will be automatically charged to the card on file. Any account over 45 days past due that cannot be processed with a credit card will be turned over to a collection agency. If amount past due exceeds \$1,000 you may be subject to legal remedy. Jurisdiction for litigation will be Fort Bend County, State of Texas. You will also be subject to court costs. If these terms are not acceptable, SPS, Knit Rite and Cascade carry our products.

Dycor pays UPS Ground shipping orders of \$100 or more on the mainland. If you need 3 Day Select, 2<sup>nd</sup> Day or Next Day air, you pay the difference from Ground.

Orders placed by 2:30 P.M. Central Time, Mon. - Thurs. and by 2:00 P.M. Fri. will be shipped the same day. We are closed the last Friday of the month.

There is a one year warranty on all Dycor products. Please record the "P" number located on the sole of the foot and record it in your client's file immediately. We will not replace any product without the "P"#. We will not replace definitive kits if they have been altered or modified in any way. Please refer to our weight chart when ordering a foot because we will not accept liability or warranty feet that have been used on men/women whose weight exceed the guidelines outlined in the weight chart. Dycor components were designed for Dycor feet. If you are using components other than Dycor you will need to replace the existing set screws with hollow point screws that will be included with the foot. Warranty is void if you do not use the hollow point screws.
